Abstracts can only be submitted **via e-mail** (<u>apraxiaofspeech2016@gmail.com</u>). The deadline for abstract submission is **22**nd **of March 2016**. All submitted abstracts will be reviewed.

Abstracts can be submitted in English. The author is responsible for the accuracy of the abstract.

The accepted abstracts will be published and distributed in the electronic online edition "Book of Abstracts of Congress of Baltic Speech and Language Therapists" on the website of the union. By submitting an abstract, the author and co-authors agree that their contact details (name, surname, affiliation, e-mail address) will be published in the Book of Abstracts.

presentation	 The oral presentation is prepared based on theory analysis or present scientific research and its results. The presentation analyses one problematic question related with the Congress theme. The oral presentation must be prepared in English. Presentation time – 15 min. Oral presentation summary must be prepared in English. There must be presented in summary: purpose of the research, methods, results, conclusions, 3 most important references of literature. Submitting tables, pictures and diagrams in the summary is not allowed.
